Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 21/11/2019.

Additional nomination forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer, Allison Valentine, at either:

- the relevant AEU Sector Council meeting at 126 Trenerry Crescent, Abbotsford VIC 3067 on 06/12/2019

OR

- via the lodgement method(s) stipulated below **not later than 12 Noon AEDT on 05/12/2019**.

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. To be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 03 9285 7177 to enquire about the status of your nomination.

Withdrawing Nominations

Nominations cannot be withdrawn after the close of nominations is announced at the meeting.

Voting Period

The Attendance ballot, if required, will open and close on 06/12/2019 at the relevant AEU Sector Council meeting.

Scrutineers

The appointment of scrutineers opens on 21/11/2019 and closes prior to the commencement of the ballot on 06/12/2019. A Scrutineer Appointment form is available from the Returning Officer.

Proxy Voting

If a member of a Council is unable to attend the meeting, they may appoint a proxy to vote on their behalf in accordance with *Rule 58 (9) Conduct of Elections at Meetings*. **The proxy must be another person eligible to vote in the relevant election.** A proxy form is included with this notice.

The appointment must be in writing and be provided to the Returning Officer before the time appointed for the conduct of the ballot
