Insufficient Nominations Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

Nominations, which must be in writing and comply with the registered rules of the Organisation, (including relevant rules regarding the minimum representation of women) may be made at any time from 24/03/2020. Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than 12 Noon Australian Eastern Standard Time (AEST) on 21/04/2020.**

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Withdrawing Nominations

Nominations cannot be withdrawn after 12 Noon Australian Eastern Standard Time (AEST) on 21/04/2020.

Candidate Statements

Candidates may submit a statement to be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 12 Noon (Australian Eastern Standard Time (AEST)) on 28/04/2020 can be accepted.

Voting Period

The ballot, if required, will open on 19/05/2020 and close at 5:00pm Australian Eastern Standard Time (AEST) on 16/06/2020.

Scrutineers

The appointment of scrutineers closes at 09:30am Australian Eastern Standard Time (AEST) on 17/06/2020. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
