## **Proxy Voting**

If a member of a Council is unable to attend the meeting, they may appoint a proxy to vote on their behalf in accordance with *Rule 58 (9) Conduct of Elections at Meetings*. The proxy must be another person eligible to vote in the relevant election.

The appointment must be in writing and be provided to the Returning Officer before the time appointed for the conduct of the ballot
